



SITE REGULATION

Mission

Respect, tolerance and mutual consideration apply at the Naturist Site Schönhalde.

General

1. Site regulations apply to all persons on the club site.
2. People on the premises register in the members' or guest book.
3. Nudism on site is the normal state, exception: dressing in cool weather, sunburn or for other valid reasons. Children decide if and when they want to be nude. We always sit on our personal towels.
4. Pedophilia, sexual abuse, sexual harassment and racism are not tolerated on the premises and are reported immediately.
5. Smoking and drug use are not permitted on the entire premises or in the buildings. Alcohol is permitted in moderation. Excessive consumption and non-compliance with smoking and drug use result with eviction.
6. Quiet applies from 10p.m to 7p.m, and 12p.m. to 1 p.m. No noise during these times. Motor vehicles may only drive onto the site in the event of medical emergency.
7. Radios and televisions may only be used outdoors when using headphones. The volume in caravans and buildings must be such that it cannot be heard outside.
8. Photographing or filming people is strictly prohibited. Family members or people having given prior consent may be photographed or filmed.
9. Visitors to the site maintain absolute discretion to the outside world and do not pass on the names or addresses of members or guests to third parties.
10. Liability and accident insurance are the responsibility of the site visitors. The Association is not liable for accidents, thefts or other losses, not for damage of any kind.

Use of swimming pool

11. The pool area is not supervised. Bathing is at your own risk.
12. The rules of conduct are binding.
13. Nude only swimming in the pool. Before using the pool, shower extensively, thus reducing the use of water treatment chemicals.



Terrain / buildings / equipment / machines / materials

14. Members ensure that all doors and gates leading out of the premises are always locked. The doors of the buildings are to be locked by the member who occupies/uses the building or the last to leave the site.
15. Only the central communal fireplace may be used for grilling. Firewood, grill grates and other utensils are for general use. Members using the fireplace make sure that it is left tidy and that the barbecue utensils are cleaned and replaced in their designated place after use.
16. Visitors on the site dispose of non-degradable waste privately. Bio degradable waste can be disposed of in the composting area.
17. Toys and sports equipment are supplied by users / parents.
18. Tools and equipment are returned clean to the respective location. Defects are reported immediately.
19. The club room and parlor of the house may be used for members' get-together. For private events the Associations rooms may be rented for a fee after consultation with the committee.
20. Storage of private equipment or objects is not permitted. Exceptions may be approved by the committee. Designated areas for deckchairs and sunshade are available.

Guests/ Animals

21. Active members are responsible for their guests. Surname and First Name are entered in the guest book, entry fee (see regulations) deposited in the cash register and guests are given the necessary information.
22. Separate rules apply to animals. They are only allowed on the premises with the committee's approval.

Parking Lots / Private Vehicles

23. Cars are parked on the parking lot outside the premises. Driving onto the site to load/unload, or parking/retrieving caravans. The parking lot next to the barn may only be used with approval of the committee and for people with walking disabilities.
24. The parking area in front of the upper gate must be kept free.
25. Motorbikes to be parked on the marked section of the parking lot.
26. Bicycles may be parked in the space next to the barn or between the club house and the fence, if space is available.
27. The Association is not liable for private vehicles either on or off site, nor for items in or on cars, motorbikes or bicycles.
